Post A.D. / Speed Post upto (so as to reach on or before) **25th March 2023 till 5pm**, with Nationalised Bank D.D. of Rs.2000/- per post for the posts of President, Vice President, General Secretary, Treasurer, Organizer and Rs.1000/- per post for the posts of Joint Secretary, Asst. Secretary, Divisional Secretary in favour of N.I.M.A. MSB payable at Nashik to the Chief Election Officer (not to the State President / Secretary / Treasurer) **or by online transfer** to the Treasurer to the Account **NIMA MSB, A/c No.38415329874 (Current Account), SBI Indira Nagar Nashik. IFSC-SBIN0014443 directly by RTGS, NEFT, etc. (transaction ID needed)** .
3. Scrutiny of nomination forms by Election Officers - **26th March 2023.**
4. Declaration of list of valid nominations on website **www.nimamsb.org** - **27th March 2023.**
5. Last Date of receive withdrawal forms - **02nd April 2023**

-: RULES & REGULATIONS :-

1. Candidates contesting for the Post of **President, Secretary & Treasurer** should have an experience of at least 3 years of working on either different Posts of Central Executive Council / State Executive Council or different sub-committees of Central / State Councils, as per the record of General Secretary of State.
2. Candidates contesting for the post of **Vice President, Organiser, Joint Secretary, Asst. Secretary & Divisional Secretary** should have an experience of at least 1 year of different posts of State Executive Committee or only Executive body post of 2 years on Local Branches (Verified & Signed by Secretary of concerned Branch with Stamp)
3. **Please send Candidate's Bio Data Form with fees details & Nomination Paper to Co-Election Officer only (# Dr.Manoj Sangale, Akola)**

Note :-

A) The Election Officers for the year 2022-2024 are appointed by the State Executive Committee meeting held on 11/12/2022.

B) Candidates themselves will be responsible for submitting the necessary documents of experience. They have to produce the proof of experience with the nomination form.
